A great deal of information can be found at ELCA.org, then clicking on the "our work" tab, and Lutheran Disaster Response is found at the lower portion of the page. Presently, there is a direct link that can be located simply by visiting the ELCA.org homepage due to the focus on recent events. I am not sure how long that will remain, but as of this writing, it is front and center.

You will find information showing both domestic and international aid opportunities. The types of disasters they address from flooding to wildfires, tornados, and so forth. One of the most common questions asked, and understandably so, is how much of my money will go to the actual people in need. That information can be found as well, stating 100% of all donations go to the designated cause. If there are additional questions, I encourage all to check out the website.

I share this due to the higher-than-normal frequency of inquiries. Should any feel inclined to offer aid, this is a reliable means to do so.


